That means Vote-By-Mail requests submitted before the November 8, 2022, General Election expired on December 31st, 2022. This affects a lot of people. If you want to renew that request, now's the time to do it.

Mr. Jones was born and raised in Lumberton, Mississippi. After graduating the 7th grade his parents moved to Belle Glade with 9 children in 1958. Later they became residents of Okeechobee Center. Mr. Jones can remember living on the corner of Carver Street and Everglades in a house referred to as the "Tin House". Mr. Jones attended FVH High School that was on the property of Okeechobee Center. As the oldest son he would help his father by going to work after school and in the summers the entire family would migrate to Delaware to continue working. His parents later purchased a home and moved. Later in 1974 Mr. Jones returned to Okeechobee center with his wife and raising their three children on Roosevelt St.



Mr. Sam Jr. & Mrs. Willie R Putman

Mrs. Putman was born in Tifton, Georgia in 1942. And moved with her family to the small town of Belle Glade when she was just a young girl. She attended elementary school and described going to the "wash house" since they did not have bathrooms in the house. Mrs. Putman migrated with her mother and 13 children for work from states to state; North Carolina, South Carolina, New York, and Virginia. She picked corn and tomatoes and traveled as a family of 13 children all siting in the back of the truck with three seats. Each year they would attend a different school depending on the state they were at when school started. Within time her mother moved to New York, while Ms. Putman stayed behind with her now husband who was already a resident of Okeechobee Center. Mr. Putman also migrated with his family for work from state to state with his parents and his six siblings. In 1971, both Mr. & Mrs. Putman moved in together to raise their family. Married since 1975 both worked for Okeelanta, Corp. Together they raised four children, two sons & two daughters along with 30 grandchildren.
